Rules & Regulations :

Rules : FIDE Rules in force shall apply

Age Limit : Players should have been born on or after 1.1.1990. Players, who are not already listed in the TNSCA Date of Birth list, must compulsorily send a copy of their birth certificate along with the entry fee. Players not listed in the TNSCA birth register and unable to produce their date of birth certificate (DOBC) can participate in the championship by paying a penalty of Rs.300/-. This will be returned to the player if the DOBC is furnished before the end of the championship. Though players are allowed to participate without DOBC on paying a penalty, they would not be eligible to claim any prize in the championship or get a certificate of participation or play in future championships unless the DOBC is furnished.

Age Limit : Complaints against suspected over-aged players could be made to the organizers who shall medically verify the players concerned.

Registration of players with AICF: All the participants must be registered players of All India Chess Federation. Those who are already registered with AICF must produce proof thereof. The AICF registration fee for the year 2009-2010 is Rs.250/-. Entries without AICF registration fee will be rejected.

Registration of participants with TNSCA is compulsory : The participants of all TN State Chess Championships are required to register themselves with TNSCA by paying Rs.70/- as registration fee every year. For the year 2009-10, the players have to remit Rs.70/- along with the duly signed TN Player's Registration Form.

Affiliates are requested to provide the players with the relevant TNSCA player's registration forms.

Mode of Tournament : 11 round Swiss

Time Control : 90 minutes each with 30 seconds increment per move from move number 1.

Entry Fee : Normal: Rs.300/- Donor: Rs.600/-

All entries, be it donor or regular, should be sent through the respective District Chess Associations. Entry fee to be paid by a Demand draft in favour of _DSKSSI Trust, payable at Chennai and sent to Solar Chess Club, c/o. A late fee of Rs.200/- per player will be collected on entries received from 12-7-2009 to 14.07.2009.

No entry will be entertained after 14.07.2009.

Note : While sending the Entries District Chess Associations should certify that their players have been selected from the selection / District Chess Championship. If such a certificate is not sent all their entries will be treated as donor entries.

Subject to age limit, the following are eligible.

- Every affiliated District Chess Association / Special Unit of TNSCA is entitled to send four entries.
- Every recognized academy of TNSCA can field two entries.
- The TNSCA General Secretary can nominate one entry.
- The top four rankers of the last TN State Under-19 Girls FIDE Rating Chess Championships organised by Mount Chess Academy, in 2008.

- The top four rankers of the last TN State Under-17 Girls Chess Championships held at Virudhunagar in 2009:

- Any player who donates the prescribed donor fee: Girls: Rs.600/-
- The host Solar Chess Club is entitled to field one additional entry.
- In the event of an odd entry, Solar Chess Club is entitled to add one more player in each category to make the total number even.
- Those who have qualified to represent the Country in official FIDE events.
- In addition to the above the following districts can field additional entries by virtue of their

players' finishing in top four of the previous TN State U-19 Chess Championship held at Virudhunagar last year:

Tiruvallur-I; Chennai-I; Kanchi-I-I; Salem-I.

- Four players from where no district association exists.

Lodging : Free Dormitory type of Lodging will be provided at the venue for outstation players plus one team manager. Those who require free dormitory type of lodging are requested to intimate the organiser on or before 11-07-2009.

Tie Break : Progressive Score tie break rules will be applied. In case of tie, prizes will not be shared.

Withdrawals : A player may withdraw at any stage of the event, after informing Chief Arbiter in writing.

Appeals Committee : A five members Appeals Committee will be formed at the Manager's meeting. The decision of the appeals committee on all protests shall be final and binding.

Chess Clocks : Each Association is requested to provide at least two chess clocks.

Protests : Protests, if any against the decision of the arbiter shall be made in writing with a protest fee Rs.300/- within 15 minutes of the incident. The protest fee is refundable only if the protest is upheld.

Arrears : The players belonging to Districts which are in Arrears to TNSCA, will not be allowed to take part in the above event

The organisers, Solar Chess Club/TNSCA reserve the rights to admit/reject any entry without assigning any reason thereof.

The organisers, Solar Chess Club/TNSCA reserve the right of admission to the venue. A person may be refused admission to the venue without assigning any reason thereof.

Accommodation : Free Dormitory accommodation for the out station players at the venue itself. The accompanying persons should have to pay. They must inform well in advance i.e on before 12th July 2009.
