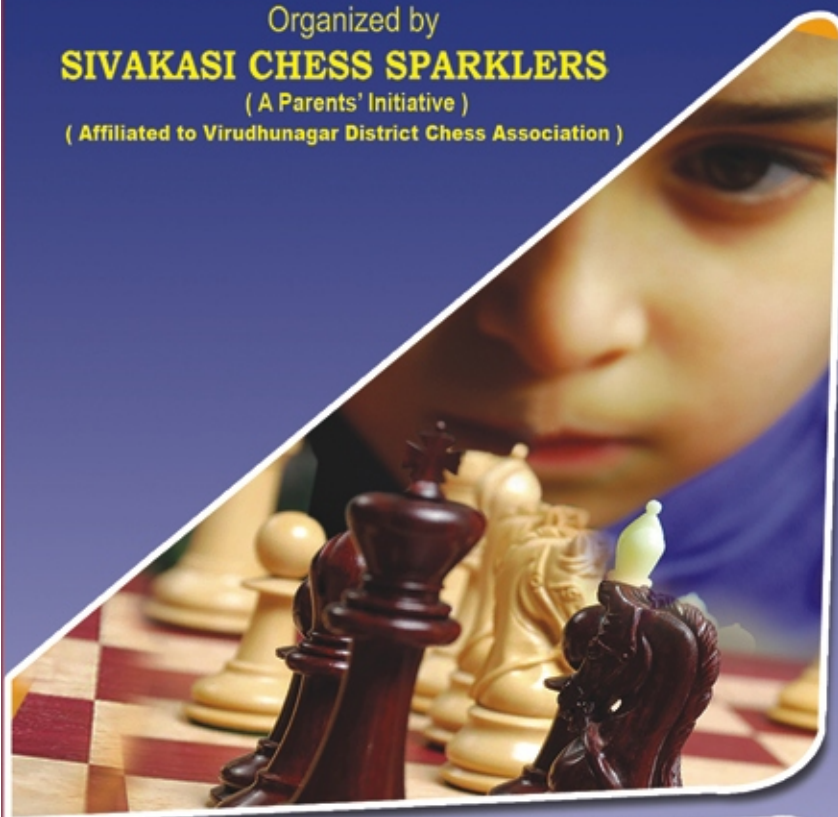

TOURNAMENT REGULATIONS

System of Play	The latest FIDE rules in force shall apply and the Swiss system will be followed.
Mode of Tournament	Total 8 rounds shall be played.
Time Control	90 minutes each + 30 seconds increment per move from move no.1
Tie break	Direct encounter, Buchholz Cut 1, Buchholz, Sonneborn-Berger and number of wins (forfeit included) tie-break systems will be applied. In case of tie, prizes will not be shared.
Default Time	15 minutes
Draw Agreement	Players shall not agree for a draw, without the consent of the arbiter before each making 20 moves.
AICF Player Registration	All the participants must be registered with AICF before they participate in the tournament. The player registration fee is Rs.250/- for the year 2018 - 2019. Those who are already registered with AICF must show proof thereof. Those who have not registered have to register by paying a fee of Rs.250/- online using the link http://aicf.in/online-player-registration along with one passport size photo and a copy of date of Birth certificate. For new players to rating tournament, the same e-mail id must not have been submitted by any other player to FIDE.
TNSCA player Registration	The participants from Tamil Nadu are required to register themselves with TNSCA by paying Rs. 150/- as registration fee for the year 2018 - 19. The amount should be remitted along with the duly signed TNSCA players Registration form plus one passport size photograph and Date of Birth Certificate copy.

VDCA Registration	VDCA registration is compulsory for Virudhunagar District players. The registration fee Rs.50/- for the year 2018 - 19.
Protests	Protests if any, against the decision of the Chief Arbiter shall be made in writing with protest fee of Rs.500/- within 15 minutes of the occurrence of the incident to the appeals committee. The protest fee will be refunded if the appeal is upheld.
Appeals Committee	Before the commencement of the Tournament, appeals committee will be formed from the senior participants present at the players meeting. The appeals committee's decisions will be final and binding on all players concerned.
Withdrawals	A player may withdraw at any stage of the event, after informing the chief arbiter in writing
Last date	Entries close at 5.00 P.M on 17.04.2018. No entry will be entertained after 5.00 P.M on 17.04.2018.
Rights of admission	The AICF/TNSCA /VDCA/organizer SIVAKASI CHESS SPARKLERS reserve the right to admit / reject any entry without assigning any reason thereof. The AICF/ TNSCA/VDCA/organizer SIVAKASI CHESS SPARKLERS reserve the rights of admission to the venue.
Certificate	Participation certificates will be awarded to all participants.
Lodging & Boarding Details	A/c and furnished double sharing room will be provided for GMs, IMs, WGMs & WIMs at the cost of organizers. For other needy participants, hostel accommodation will be provided on twin sharing basis, together with quality food at a cost of Rs. 400/- per person for 4 days. Players are requested to bring their own beddings. The amount has to be remitted along with the entry fee before 15th April. Then only the accommodation and food will be confirmed. Others have to take their food in the college canteen. Kindly take note that there is no hotel nearby.
Transport Facilities	The venue is about 11 KMs from Sivakasi and 15 KMs from Virudhunagar. College buses will be available at 8.00 A.M. near Sivakasi bus stand & Virudhunagar old bus stand. City buses are available between Sivakasi & Virudhunagar. Participants are requested to book their train tickets from Virudhunagar to catch the trains after 8.30 P.M.
