Rules & Regulations

Rule: The tournament will be played under the latest FIDE Rapid rules.

Rate of Play: 25 minutes each, plus 5 seconds increment per move from move one.

AICF player Registration: AICF Player registration is compulsory for all players. AICF Player Registration fee is Rs.250/- for the year 2018-2019. AICF players registrations will be accepted only through online.

Players/ Arbiters registration should be done well before the start of the Tournament. For renewing AICF Registration of existing players please click <http://aicf.in/players/>. For fresh AICF Registration go to <http://aicf.in/online-player-registration/>. For fresh AICF registration, players are requested to keep their scanned passport size photograph and birth certificate and a valid email address (unique) not used by any other person/player for AICF, ready before the registration process.

(Note: Only passport size (less than 1MB) photograph in jpeg format should be uploaded)

TNSCA player Registration Fee: All Tamil Nadu players are required to register themselves with TNSCA by paying Rs.150/- as player registration fee for the year 2018-19. The amount should be remitted along with the duly signed TN players Registration form, plus one passport size photograph and Date of Birth Certificate copy. Those who have already paid must show the proof thereof.

CDCA Registration: All Chennai players are required to register themselves with CDCA by paying Rs.100/- as registration fee for the year 2018-19.

Tie-break: In case of a tie following rules will be applied. In the following order Direct encounter, Buchholz cut 1, Buchholz, Sonneborn-Berger and number of wins. (Including forfeit games)

Prize money will not be shared

Protests: Protests, if any, against the decision of the Chief Arbiter shall be made in writing with a fee of Rs. 500/- within 15 minutes of the occurrence of the incident to the appeals committee. The protest fee will be refunded if the appeal is upheld.

Appeals Committee: An Appeals Committee comprising of five members will be formed at the players meeting. The decision of the appeals committee is final and binding on all players concerned.

Withdrawals: A player may withdraw at any stage of the event, after informing the Chief Arbiter in writing.

Accommodation: Players have to make their own arrangements. The organizers, on request, shall assist in finding a suitable accommodation. Contact Organising Secretary Vishnu Priya 8667558108
