6. Tiebreak: Buchholz tiebreak system will be applied. In case of tie, prizes will not be shared.
7. The Chief Arbiter's' decisions' shall be final and binding on all players concerned.
8. Age proof Certificate must be produced for Children's category prizes.
9. Entries close at 5.00 P.M on 24.11.2021 No entry will be entertained after 5 P.M on 24.11.2021 Strictly no Spot Entries.
