RULES AND REGULATIONS

| Eligibility | (a) All affiliates of the TNSCA (b) Academies / Clubs/Schools /Colleges / Educational institutions affiliated to any of our District Chess Associations; Players cannot participate in any State Championship without the written consent of their District Association or Special Unit.(c) Each district can send as many as teams possible. Age proof is required. Certificate should be from the Panchayat/Municipality or corporation obtained soon after birth. Players without the date of birth certificate will not be allowed to participate. As per the rules of AICF, only players whose dates of birth are registered within one year of their birth are permitted to take part in respective age group state/nationals.Other country passport holders shall not be allowed to participate in the State Chess Championship. |

| Team composition | Each team will consist of Maximum Five. Each team match will be played on four boards. A team's Fixed Board Order (FBO) for the whole championship shall be given in writing at the Captains' meeting which shall be final. Board replacement in any round shall be in ascending order. Fifth board player can play on Board 4, Fourth board player can play only on Fourth or Third board (if any player of the higher board is rested) and so on. Order for each round (Round Team List - RTL) shall be submitted to the Chief Arbiter within the time frame specified at the Captains' meeting. If a team does not submit any board order for any round, only their first four players according to their fixed board order can play in that round. Free Unfurnished Dormitory Lodging will be provided at the venue for the |
| Canteen Facility: | participating team & its district representative. All are requested to bring their bedding, etc. Accompanying persons have to make their own arrangements. Hotels are very nearby to the venue. |
| AICF Player Registration | Single window registration of AICF, TNSCA and the District Association will be followed with a payment of Rs.250/- for all the three registrations put together for the year 2022-2023. The player registrations will be accepted only through online on www.aicf.in. Players / Arbiters registration should be done well before the start of event (Tournament). | Chess Clocks: | Each Association is requested to provide at least two chess clocks for every team. | | |
| Appeals Committee: | An Appeals Committee comprising of five members plus two reserves will be formed at the managers meeting. All the members and reserves shall be from different districts. No member of committee can vote on dispute in which a player from his own district/states is involved and in such case(s), the reserve member takes his place. The decision of the appeals committee is final and binding on all players concerned. | | |
| Tournament Committee: | The tournament committee consisting of the General Secretary, TNSCA or his representative, and representative from another district to be nominated by the TNSCA shall decide on all emergency matters. | | |
| Protest: | Protest, if any against the decision of the Chief arbiter shall be made in writing with a protest fee of Rs.500/- within 15 minutes of the incident. The decisions of the appeals committee shall be final and binding on all concerned. The protest fee is refundable one if the protest is upheld. | | |
| Withdrawals: | A player may withdraw from the tournament at any stage after informing the Chief Arbiter in writing. | | |
| Arrears: | The players belonging to Districts which are in arrears to TNSCA will not be allowed to take part. | | |
| Rights of Admission: | The AICF/TNSCA/MDU DCA/ Organizer GKCA reserve the rights of admission to the venue and lodging place. | | |
| Wrist Watches | AICF has banned the wrist watches while playing in FIDE Rated events. Players are instructed not to wear wrist watches while playing. | | |
