TOURNAMENT RULES:

- 1) **SYSTEM OF PLAY**: The tournament will be conducted as per FIDE Laws of chess & FIDE Swiss System with 9 Rounds. Time control will be 25 minute + 05 Sec. increment per move from move 1.
- 2) Default time 15 Minutes

- 3) Latest FIDE Rapid Chess rules will be applicable with suitable tie break system.
- 4) Appeals Committee of 5 members with 2 reserves with the senior participants / officials present at players meeting will be formed before the commencement of tournament.
- 5) Protests: Protests, if any against the decision of the Chief Arbiter, shall be made in writing with a protest fee of Rs. 500/- within 10 minutes of the occurrence of the incident. The amount will be refunded if the appeal is upheld.
- 6) The decision of the Appeals Committee will be final and binding on all the players.

- 7) Denial of Entry: CDCA/TNSCA reserves the right to admit / refuse any entry without
- 8) The organizers of the tournament reserve the right to make necessary changes in rules pertaining to the tournament
- 9) Smoking /Drinking is strictly prohibited in the premises of tournament.
- 10) Players are requested to get their own chess clocks.

- 11) RIGHTS OF ADMISSION:- Any players who had played unauthorized tournament listed by All India Chess Federation are not allowed to participate in this tournament.
- 12) AICF Player registration is mandatory for all players for the period 2016-17. All the participants must be registered with AICF. The registration fee is Rs.250/- for the year 2016-2017. Those who are already registered with AICF must show proof thereof. Those who have not registered can get registered by paying a fee of Rs.250/- and filled in registration form along with one passport size photo and a copy of date of Birth certificates. E-mail id of the player is compulsory.
- 13) TNSCA Player registration is mandatory for all TN players. Registration fee **is** Rs.100/for the year 2016-17. The amount should be remitted along with the duly signed TN players Registration form plus one passport size photograph and Date of Birth Certificate copy
- 14) Chennai DCA player registration for all Chennai players. Players without above registrations must register at the venue before the start of the tournament by paying the relevant fees.
- 15) Players have to arrange their own accommodation.
