- FIDE Rapid rules in force shall apply and the Swiss System will be followed
- Time Control: 15 Min + 3 Sec increment per move from move no.1.
- First Round starts at 9 .30 AM on 7th December 2025. The number of rounds and the round-wise schedule will be announced at the tournament venue.
- Last date for entries is 4th December 2025.
- No Spot entries allowed
- All participants must be registered with TNSCA. The Player registration for the year April 2025 to March 2026 is Rs 150/-

- CGDCA Registration fee 2025-26 - Rs. 75/- (Applicable for CGDCA players only) should be paid through the <https://www.easypaychess.com/membership.asp> link

- Tie break: Latest AICF tiebreaks will be applied. In case of tie, prizes will not be shared.
